# PLAINTIFF'S ORIGINAL PETITION FOR ABATEMENT OF A COMMON NUISANCE, AND APPLICATION FOR TEMPORARY RESTRAINING ORDER, TEMPORARY INJUNCTION, AND PERMANENT INJUNCTION

El Paso County Attorney Christina Sanchez brings this suit on behalf of the State of Texas, to enjoin and abate a common nuisance, and files this Original Petition for Abatement of a Common Nuisance, and Application for Temporary Restraining Order, Temporary Injunction, and Permanent Injunction against the named defendants, including an *in rem* defendants, pursuant to the Texas Civil Practices and Remedies Code (CPRC). Defendants maintain and/or assist in maintaining a common nuisance at a lodging establishment, known as "Gateway Hotel" (hereinafter "the Gateway") located at 104 S. Stanton., El Paso, Texas 79901.

## I. SUMMARY

Gateway Hotel is lodging establishment in downtown El Paso. The building was erected in 1903 and became the Gateway Hotel in 1927-28 under renovation by Trost & Trost. The previous owner was convicted for smuggling and money laundering in a federal case in 2011. The Gateway was condemned by the City of El Paso in 2014 and the building was to remain vacant until it was rehabilitated, and a certificate of occupancy was issued. **Exhibit 1 – Record Condition** 

Notice. Defendant Yun purchased the hotel in 2015. Exhibit 2 - "El Paso Gateway Hotel restoration an ongoing labor of love for South Korean immigrant" June 20, 2018 article in the El Paso Times by Vic Kolenc. Defendant Yun started restoring the Gateway and was granted a "Conditional Certificate of Occupancy" on May 22, 2018 that allowed for the partial use of the lobby and full use of the first floor. This conditional certificate of occupancy expired on November 22, 2018. Exhibit 3 – Conditional Certificate of Occupancy. A search of records reveals that a new certificate of occupancy has not been issued, and while Gateway has operated as a hotel for the past six years, it has done so without a valid certificate of occupancy and in violation of city requirements. For the last two years, there have been six hundred and ninety-three (693) calls for service to the hotel. The large volume of calls for service to a single business and State's analysis of police reports show that the Gateway has habitual criminal activity that violates the CPRC, and additional crimes that contributes to the overall blight this business brings to downtown El Paso. A list of this activity is organized in **Exhibit 4 – violation chart**. A video showing the deplorable state of the inside of the building and the type of activity allowed inside of the business comes from an aggravated assault case. The video shows dozens of people "partying" on the 3<sup>rd</sup> floor of the hotel, drinking, smoking and dancing provocatively while children are present. The video also shows at least one gun being shot, another used to threaten, men holding knives and another man with a hatchet assaulting people and causing damage to the hotel in front of a security guard. Exhibit 5, still pictures from security footage of aggravated assault on June 16, 2024. To add to the criminal nuisance of this building, and in addition to building's absence of a certificate of occupancy, the building has failed at least three inspections by the El Paso Fire Department since July. Exhibits 6 - 8, inspections from the El Paso Fire Department. While the County Attorney's Office does not have jurisdiction to enforce the City's code violations, they give a

complete picture of the building itself and the conditions where the habitual criminal activity occurs. Affidavits from El Paso Police Department (EPPD) Officers note habitual criminal activity, trash and fire hazards. Most alarming is an increase of suspected gang members using the property. Exhibits 9 – Affidavit of Officer Samuel Medina and Exhibit 10 – Affidavit of Officer Dionicio M. Alvarez. The Officers' observations are documented and counted in exhibit 4. In his affidavit, Officer Medina suspects prostitution from the hotel, and notes the "continuous incidents of criminal activity" has increased "with the introduction of the Tren De Aragua organization into the hotel." Exhibit 9. Similarly, Officer Alvarez points out that management does not attempt "to control the conduct of the guests and is negligently allowing gang activity to infiltrate the area." He also observes the general reputation of the Gateway for "allowing illegal activity (consuming drugs, gang activity, illegal dumping) and known not to make necessary changes to prevent the illegal activities" and that "This establishment will continue to threaten public safety if allowed to conduct 'business as usual." Exhibit 10.

# II. PARTIES

1. Plaintiff, the State of Texas, appears and is represented by and through the El Paso County Attorney Christina Sanchez, with her principal office located at 320 S. Campbell St., Suite 200, El Paso, Texas 79901, and is duly authorized under Chapter 455 of the OCC, Chapter 125 of the CPRC, and Chapter 455 of the OCC, to bring this cause of action to restrain, enjoin, and have abated activities declared to be a common nuisance. The State is not required to verify facts in support of the requested injunctive relief to abate the nuisance activity.<sup>1</sup>

- 2. Defendant "Gateway Hotel," (hereinafter, "Gateway Hotel") is an *in rem* business owned by Howard Yun.<sup>2</sup> Service of citation may be had upon Gateway Hotel by serving the person in care, custody, control or management of Gateway Hotel or the registered agent, Howard Yun, 219 E. Mills Ave. El Paso, Texas 79901, or wherever he may be found. The business does not have an active assumed name registered in El Paso County.
- 3. Defendant the real property known as 104 S. Stanton St., El Paso Texas 79901, is an *in rem* property owned by Howard Yun. Service of citation may be had upon 104 S. Stanton, El Paso Texas 79901, by serving the person in care, custody, control, or management of 104 S. Stanton, El Paso Texas 79901 or the registered agent, Howard Yun, located at 219 E. Mills Ave. El Paso, Texas 79901 or wherever he may be found. The business does not have an active assumed name registered in El Paso County.
- 4. Defendant, Gigante Enterprises LLC, is a Domestic Limited Liability Company, and owns the business known as "Gateway Hotel" and the real property known as 104 S. Stanton, El Paso, Texas 79901<sup>3</sup> Service of citation may be had upon defendant by serving the registered agent, Howard Yun, at 219 E. Mills Ave. El Paso, Texas 79901, or wherever he may be found.
- 5. Defendant Howard Yun is the owner of Defendant Gateway Hotel. Service of citation may be had on Howard Yun at 219 E. Mills Ave. El Paso, Texas 79901 or wherever he may be found.
- 6. Plaintiff invokes the right to institute this suit against Defendants, or any other name which

has been used to designate them, or which they have used. Plaintiff expressly invokes Rule 28 of the CPRC to have the true name of these parties substituted at a later time upon the motion of any party or the Court, in the event any party is not correctly named or not included.

## III. DISCOVERY

7. The State intends for this case to be governed under Level II Discovery in accordance with § 190.3 of the Texas Rules of Civil Procedure. The State affirmatively pleads this case is not governed by the expedited actions process in § 169(c)(1)(b) of the Texas Rules of Civil Procedure because the relief sought by the State includes non-monetary injunctive relief.

# IV. <u>JURISDICTION AND VENUE</u>

- 8. Venue is proper in El Paso County, Texas because all or part of the acts or omissions giving rise to Plaintiff's claims occurred in El Paso County, Texas, and the property upon which Defendants maintain a common nuisance, or are about to maintain a nuisance, is in El Paso County, Texas.<sup>4</sup>
- 9. This Court has subject matter and personal jurisdiction over the cause and parties for the State's Application for Temporary and Permanent Injunctions based on the CPRC. The real property made the basis of this cause of action is a common nuisance as maintained.<sup>5</sup>

## V. FACTS

10. The Gateway Hotel's reputation is as a business that does not properly document the guests that stay at the hotel, has narcotics trafficking, disorderly conduct, and violent crime.

Exhibits 4, 9 and 10.

11. Affidavits from Officers detail law enforcement interactions at the Gateway and describe conditions and experiences that support the Gateway's reputation that it is not run as a legitimate business. Aside from numerous City ordinance violations, the Gateway has a significant problem with crime that defendants do not take reasonable efforts to abate.

Exhibits 4, 9 and 10.

12. Crimes prohibited by Chapter 125 of the CPRC are habitually committed at Gateway Hotel.

As noted in **exhibit 4**, there are fifty-three (53) CPRC violations from August 2022 – August 2024 and include but are not limited to at least:

- a. Eleven (11) for Delivery, possession, or use of a controlled substance.<sup>6</sup>
- b. Ten (10) aggravated assault<sup>7</sup>;
- c. Five (5) criminal trespass<sup>8</sup>
- d. Twenty (20) instances of disorderly conduct<sup>9</sup>:
  - a. Thirteen (13) for assaultive conduct/fights;
  - b. Two (2) for terroristic threat;
  - c. Two (2) public intoxication
  - d. One (1) Indecency w/child

- e. Two (2) Disorderly conduct/actions
- e. Six (6) criminal mischief <sup>10</sup>;
- f. One (1) arson<sup>11</sup>
- 13. In addition to the criminal activity that violates the CPRC, other crimes habitually occur at Gateway, including at least:
  - a. Seven (7) theft<sup>12</sup>
  - b. Six (6) Burglary<sup>13</sup>
  - c. One (1) Failure to Comply with Sex Registration <sup>14</sup>
  - d. Three (3) instances when suspected gang members were present
- 14. Despite direct knowledge of the criminal activity occurring on the property, defendants have not made a reasonable attempt to abate the activity.<sup>15</sup>
- 15. Defendants refused or failed to cooperate with law enforcement by not providing video surveillance when asked on several occasions, and employees or the owner were often reluctant to cooperate when they did. <sup>16</sup> See exhibit 4.
- 16. The frequency of the violations described above is prima facie evidence that the defendants' collectively and knowingly tolerate the criminal acts. <sup>17</sup>
- 17. Gateway Hotel is a place where persons have habitually violated and/or will likely continue to violate provisions of the CPRC.<sup>18</sup>
- 18. In addition to the habitual criminal activity occurring at Gateway Hotel, the problems are

exacerbated because at least ninety (90) city ordinance violations are noted. **Exhibit 4 and** discussed in exhibits 9-10.

- a. Trash is stored/kept continuously on the floors in an unsanitary condition;
- b. Occupants smoke inside the business and do not properly dispose of cigarette butts, often leaving them on the hallway floor (see **exhibit 5**);
- c. Fire exits are usually impeded or blocked;
- d. Other fire code violations are consistently present. The Gateway has been in violation of the El Paso City Fire Code since at least July 11, 2024; however, the nature of the violations listed in **exhibits 6-8** suggest that the violations are persistent. It also appears there was an inspection before July, as Officer Medina mentions seeing an inspection from the El Paso Fire Department that was conducted in April as noted in **exhibit 9**;
- e. The building does not have a certificate of Occupancy. On November 22, 2018, the Conditional Certificate of Occupancy issued to the Gateway by City of El Paso Planning and Inspections on May 22, 2018 expired. The Conditional Certificate of Occupancy only allowed use of the Lobby and the first floor. **Exhibit 3.** The business has operated since November 22, 2018 without a certificate of occupancy, and there is evidence that the defendants allow people to stay on condemned floors that never had a certificate of occupancy since the building was condemned in 2014. **See exhibits 1, 3 10.** If every day the hotel has operated without a certificate of occupancy is included, the number of violations skyrockets.
- f. Some on-line reviews of Gateway Hotel supports affidavits from law enforcement that Gateway Hotel has a general reputation for being a hotel that is not a clean

# place to stay. <sup>19</sup> Exhibit 11.

# VI. APPLICABLE LAW AND STATUTORY AUTHORITY

## B. Temporary and Permanent Injunction

- 19. A person maintains a common nuisance if they maintain a place to which persons habitually go for any of the purposes listed in the CPRC and they "knowingly tolerate the activity and fail to make reasonable attempts to abate the activity."<sup>20</sup>
- 20. The CPRC provides that "[p]roof that an activity described by Section 125.0015 is frequently committed at the place involved or that the place is frequently used for an activity described by Section 125.0015 is prima facie evidence that the defendant knowingly tolerated the activity." Evidence of the general reputation of the place involved is admissible to show the existence of the nuisance. <sup>21</sup> In addition, evidence that persons have been arrested for or convicted of offenses for an activity described by Section 125.0015 in the place involved is admissible to show knowledge on the part of the defendant that the prohibited conduct occurred. <sup>22</sup>
- 21. Relevant violations of the CPRC committed at Gateway Hotel include, but are not limited to:
  - a. Sec. 125.0015- Direct knowledge of activity and does not make reasonable attempts to abate;
  - b. Sec. 125.0015(a)(4) delivery, possession, manufacture, or use of a substance or other item in violation of Chapter 481, Health and Safety Code;
  - c. Sec. 125.0015(a)(9) aggravated assault as described by Section 22.02, Penal Code;
  - d. Sec. 125.0015(a)(23) criminal trespass as described by Section 30.05, Texas Penal Code.
  - e. Sec. 125.0015(a)(24) disorderly conduct as described by Section 42.01, Texas Penal Code.

- f. Sec. 125.0015(a)(25)-arson as arson as described by Section 28.02, Texas Penal Code
- g. Sec. 125.0015(a)(26) criminal mischief as described by Section 28.03, Texas Penal Code.
- h. Sec. 125.004(c)- Evidence of general reputation of the place involved is admissible to show the existence of the nuisance.
- i. Sec.125.004(d)- Evidence that the defendant refused to cooperate with law enforcement or emergency services with respect to the activity is admissible.
- 22. A county attorney has authority to enjoin and abate a nuisance in the county where the nuisance exists. The suit may be brought against any person who maintains, owns, uses or is a party to the use of a place for purposes constituting a nuisance, and may bring action *in rem* against the place itself. All named Defendants either maintain, own, use or are a party to the use of the property.<sup>23</sup>
- 23. If, after notice and hearing on a request by a plaintiff for a temporary injunction, a court determines that the plaintiff is likely to succeed on the merits in a suit brought under the CPRC, the court shall require that each defendant execute a bond.<sup>24</sup> The bond must be payable to the State of Texas at El Paso County; be in the amount set by the court, but not less than \$5,000.00 or more than \$10,000.00; have sufficient sureties approved by the court; and be conditioned that the defendants will not knowingly allow a common nuisance to exist at that place.
- 24. Should any condition of bond or any injunctive order by a court be violated, suit upon the bond in the name of the State of Texas should be allowed; and upon a showing of a violation of any condition of the bond or injunctive order, the whole sum of the bond should be ordered forfeited to the originating entity.<sup>25</sup> Further, the court may impose a laundry list of sanctions under § 125.045(b), including cutting off utilities to the place, revoking the

occupancy permit, prohibiting access through public streets or alleys, limiting hours of operation, ordering termination of the tenant's lease, or any other legal remedy available under the laws of Texas. Subsequent to the bond forfeiture, the court shall order the place where the nuisance exists closed for one year from the date of the order of bond forfeiture.<sup>26</sup>

# VII. REQUEST FOR RELIEF

- 25. The State incorporates, adopts, re-alleges by reference the allegations contained in each and every preceding paragraph of this petition.
- 26. Violations that occur at Gateway Hotel are common nuisances within the meaning of CPRC. There have been at least one hundred fifty-three (53) violations of the CPRC.
- 27. The Defendants have failed or refused to abate the nuisances and are likely to continue to maintain Gateway Hotel as a common nuisance unless restrained by injunctive orders, so the State requests temporary injunctive relief against the named Defendants, enjoining them from operating in violation of the CPRC.
- 28. After notice and a hearing, if the court determines that the State is likely to succeed on the merits, the court shall order reasonable requirements to prevent the use and maintenance of Gateway Hotel as a nuisance and require each Defendant to execute a bond. <sup>27</sup> Each bond must be payable to the State of Texas at El Paso County; be in the amount set by the court, but no less than \$5,000.00 nor more than \$10,000.00; have sufficient sureties approved by the court; and be conditioned that each defendant executing a bond will not knowingly allow a common nuisance to exist at that place.
- 29. Should any condition of the bond or any injunctive order by this Court be violated, suit

upon the bond in the name of the State of Texas should be allowed; and upon a showing of a violation of any condition of the bond or injunctive order, the whole sum of the bond should be ordered forfeited to El Paso County.<sup>28</sup>

30. A court that determines a vacant, abandoned or multiunit residential property is a common nuisance, the court may, on its own motion or on the motion of any party, order the appointment of a receiver to manage the property or render any other order allowed by law as necessary to abate the nuisance.<sup>29</sup>

## C. Permanent Injunction

31. The State incorporates, adopts, re-alleges by reference the allegations contained in each and every preceding paragraph of this petition.

32. The State requests permanent injunctive relief against Gateway Hotel, enjoining Defendants from operating in violation of the CPRC.

33. If successful, the State requests the Court order the named Defendants to abate the nuisance and enjoin them from maintaining or participating in the nuisance. The State requests the Court to order reasonable requirements to prevent the use or maintenance of the place as a nuisance.<sup>30</sup>

34. As Gateway Hotel and the Property are named as *in rem* defendants, the State requests the Court order a judgment *in rem* and order the place where the nuisance exists to be closed for one year after the date of judgment.<sup>31</sup>

35. If a defendant violates any condition of the bond or any injunctive order of this Court, the El Paso County Attorney shall sue on the bond in the name of the State. Upon a showing

of a violation of any condition of the bond or injunctive order, the whole sum of the bond, plus costs and attorney fees, should be ordered forfeited to El Paso County, Texas, the originating entity. Subsequent to the bond forfeiture, the court shall order the place where the nuisance exists closed for one year from the date of the order of bond forfeiture. <sup>32</sup> In addition, the court may impose the laundry list of sanctions under CPRC§ 125.045(b); including cutting off utilities to the place, revoking the occupancy permit, prohibiting access through public streets or alleys, limiting hours of operation, ordering termination of the tenant's lease, or any other legal remedy available under the laws of Texas.

- 36. A person who violates a temporary or permanent injunctive order is subject to the following sentences:
  - a. fine of not less than \$1,000.00 nor more than \$10,000.00;
  - b. confinement in jail for a term of not less than 10 nor more than 30 days;
  - c. both a fine and confinement.<sup>33</sup>

# VIII. DEMAND FOR JURY

The State demands a jury trial.

# IX. CONDITIONS PRECEDENT

All conditions precedent to the State's claim for relief have been performed or have occurred.

# X. <u>ATTORNEY'S FEES</u>

issue an order in rem against Gateway Hotel and the property located at 104 S. Stanton, El Paso

Texas 79901, and all named defendants, appear at a hearing within 14 days for a temporary

injunction hearing. The State prays that no bond be required.

## El Paso Gateway Hotel restoration an ongoing labor of love for South Korean immigrant

The Gateway Hotel at 104 S. Stanton St., in Downtown El Paso, is being renovaled by owner Howard 'Danny' Yun. He's reopened one floor with 25 rooms and hopes to have all 100 rooms open by the end of the year. RUDY GUTIER

Howard "Danny" Yun has spent the past three years cleaning and renovating Downtown El Paso's historic Gateway Hotel, which was closed four years ago after being used in an immigrant smuggling ring.

"This building was terrible" when he became owner of the 112-year-old, five-story building in 2015, said the 72-year-old South Korea native who immigrated to the  $\,$ United States almost 40 years ago. He's lived in El Paso 37 years.

"We threw away 20 containers of junk," chimed in Jay Park, 60, Yun's longtime friend — whom Yun calls his brother — who has been a big part of the renovation.

Yun reopened part of the hotel June 1 — the second floor with 25 rooms.

The three other floors with 75 rooms still are under renovation with lots of work remaining.

His goal is to have the entire hotel completed by the end of the year, he said.

It's located at 104 S. Stanton St., across the street from the now vacant, former J.C. Pennev store.

#### Low-budget way station

It's only a block away from the new, hip Marriott Aloft hotel in the renovated, 15story Bassett Tower, but the Gateway is in a totally different hotel world.

The Gateway's long been a low-budget way station for mostly travelers from Mexico. And it will continue that way. The smallest rooms with a single bed cost \$38 per night; a large room with a queen bed costs \$58 per night, and the largest rooms with king beds cost \$58 per night.

The ground floor lobby has been refurbished, and a large, ground-floor restaurant space was remodeled for a prospective lessee. Several ground-floor retail spaces remain empty because Downtown business is slow, Yun said. A women's clothing shop moved into one small retail space about a year ago.

Yun's racked up a debt of about \$1.75 million — much of it on credit cards — to pay for materials, labor and property taxes, including thousands of dollars in back taxes owed by the previous owner, he said.

No bank loan officers would give him a loan, he said.

## Saving history

"I didn't know all the problems when I bought the building," Yun said. "Many people said, 'Don't touch this building,' even my wife"

Ron Roth, a chief building inspector for the city of El Paso, said: "The building was in pretty bad shape. That's the reason we had the building vacated (in 2014)."

"Fortunately, it's a structurally sound building," he said.

"I think it's an important building. It's not on the historical register. But we want to preserve all that we can," Roth said.

Yun bought the hotel in 2015 because it's a historic building that's important to save for Downtown, he said.

"We have to keep the history. Heritage is very important," he said.  $\,$ 

"A lot of people remember this hotel when they were growing up and their parents stayed here," Yun said. "Pancho Villa (the late Mexican revolutionary) stayed here."

#### Restoration brings stress, anxiety

Yun immigrated from South Korea, first to California in 1979 and then to El Paso around 1981.

Years ago, he operated a tae kwon do studio Downtown and a Downtown general merchandise store, he said. He helps his wife, Grace Yun, operate her women's clothing store, Bella Boutique, at 408 S. El Paso St., in Downtown, he said.

But the hotel restoration project takes most of his time, he said.

While high-profile building owners with big budgets and big work crews have been busy renovating several other Downtown historic buildings into hip or high-end hotels, Yun has patiently and sometimes painfully carried on at the Gateway with only a handful of people. He and Park do most of the cleaning while a general contractor oversees the construction, Yun said.

"I've had a lot of stress and anxiety" because of this building, Yun said. "I lost weight. I had to go to the hospital."

The city's Roth said he's been working with Yun and Park as they "piecemeal it back together. It's taken them awhile, but they keep plugging along."

"They are a couple of hardworking guys, and persistent," he said.

#### Wood floors back to old glory

The hotel's five-story exterior was repainted. Two old Gateway Hotel signs, including a huge one on the roof, remain.

New electrical wiring and new plumbing have been installed in the hotel. New sinks and toilets are being put in the guest rooms' tiny bathrooms. Chemicals are being used to remove years of grit and rust from bathtubs. Rooms are being equipped with individual heating and cooling units.

Original wood floors inside the 25 now-open guest rooms have been refinished to their past glory. Wood floors will be redone in all 100 rooms, Yun said.

New and used furniture and new mattresses have been placed in the completed rooms. Yun has bought mirrors and paintings from five-star hotels to put in rooms and hallways, he said.

Carpet has been laid in the second and third floor hallways. The mosaic of tiny, white ceramic tiles still is visible on the hallway floors on the fourth and fifth floors. The ceramic floors were too bad to restore on the lower floors, Yun said. But now, he's debating whether the antique floors are worth saving on the upper

#### Years of neglect still evident

Work continues on the third, fourth and fifth floors, where the dilapidation from years of neglect still is on display. A previously leaky roof damaged ceilings and walls. The plumbing was rotten.

"That's my job. To clean this up," Yun said as he pointed to small piles of concrete on a hallway floor next to where a hole was made in the wall to install new water lines.

Bird droppings cover portions of floors in two fifth-floor rooms. Many birds and bats got through broken windows and had to be removed from the building when Yun began renovation three years ago, he said.

About 150 windows have been replaced, he said.

#### Past scarred by smuggling ring

The Gateway Hotel opened in 1928 after being converted from an office building by Trost & Trost, the famed El Paso architectural firm headed by the late, prolific and iconic Henry Trost, according to the building's history written for the El Paso Public Library and posted on the Henry Trost Historical Organization's website.

The exterior of the hotel was in a scene shot for 2004's "Glory Road" movie, about Texas Western College's 1966 national basketball championship team. And the hotel also was in 1972's "The Getaway," starring the late actor Steve McQueen.

The hotel's more recent history is as ugly as the hotel's deterioration, leading the

city to shut it down in 2014 as a safety hazard, forcing people to move out.

The previous operator of the hotel, Song U. Yun's wife and a friend, David Yoon, owned the hotel building several years prior to Chon's agreeing to buy it, Howard Yun said. In 2015, they took back the building through foreclosure and that same year sold it to Howard Yun, he said.

"I don't want to sell it," Yun said of what has become his labor of love. "I promised to myself to fix it."

### **AFFIDAVIT**

STATE OF TEXAS §

COUNTY OF EL PASO §

Before me the undersigned authority, on this day, personally appeared Officer Samuel A. Medina #3336, who being duly sworn and upon oath stated:

"My name is Samuel A. Medina. I am over 21 years of age, of sound mind, capable of making this affidavit, and have personal knowledge of the facts stated within this document. I affirm the facts stated herein are true and correct to the best of my knowledge and I am competent to testify to these facts.

Affiant is employed as a Police Officer with the El Paso Police Department (EPPD) in El Paso County, Texas and has been employed as such since January 22, 2019. Affiant is presently assigned to the Central Regional Command Center (CRCC) Metro Unit in El Paso, TX. Affiant along with the Metro Officers noted below conducted business check operations and responded to criminal calls for service at the Gateway Hotel located at 104 S. Stanton St. in the City of El Paso, El Paso County Tx. 79901. Further details of the investigations and conversations, noted below, are in EPPD case number reports.

On Wednesday, April 17th of 2024, at approximately 2145 hours, Officers J. Holmes #3199, A. Hernandez #3468, A. Perez #3482 and M. Lopez #3516 responded to 104 S. Stanton #317 (Gateway Hotel) reference a subject disturbance. Upon arrival the officers were flagged down by Blanca Arredondo de Romero (Mother of Moctezuma Arredondo) reference an aggravated assault. The Officers observed M. Arredondo had a deep laceration over his left eye just above the eyebrow, and a swollen left hand. The Officers requested FMS to the scene for injuries to M. Arredondo. Officers Lopez placed a bandage around M. Arredondo's head to stop the bleeding. While at the scene Officer Holmes spoke to B. Arredondo de Romero who stated she had got into an argument with M. Arredondo because he had been drinking. B. Arredondo de Romero stated she had yelled for someone to call the police, because she felt M. Arredondo could get violent. B. Arredondo de Romero stated that several Hispanic Males from Venezuela entered the room and beat up M. Arredondo. B. Arredondo de Romero did not know what weapons were used if any. FMS pumper 1 and rescue 1 responded and M. Arredondo was transported to UMC. The officers followed the blood trail to room 317. The officers observed the room to be in disarray with a blood trail beginning on the right side of the bed and leading out the door. Officers Lopez and Perez conducted a follow-up at UMC Hospital to meet with M. Arredondo. M. Arredondo stated that he got into an argument with his mother (B. Arredondo de Romero) and that whenever they get into an argument, B. Arredondo de Romero leaves the room to calm down. According to M. Arredondo, once B. Arredondo de Romero exited the room, a group of migrants (unsure how many) went inside the room and assaulted him with blunt objects. M. Arredondo then pointed to his forehead to show the officers how he got the laceration to his forehead and the swollen left hand. M. Arredondo mentioned that this is not the first time that he

has gotten assaulted by the same group of people; however, he does not like to call 911 for assistance.

On Sunday June 16th of 2024, Officer P. Paoli #3155, was dispatched to 104 S. Stanton (Gateway Hotel) in reference to a stabbing in progress. Upon arriving on scene, Officer Paoli met with Veronica Miranda Gutierrez (Clerk for the hotel) who advised that she had seen Francelus Coronado (Tenant) suffering from multiple stab wounds after an altercation occurred on the third floor. Gutierrez said Coronado was part of a rather large group of individuals partying on the third floor and that some sort of altercation broke out that resulted in Coronado being stabbed multiple times. Gutierrez went on to say that "they" (immigrants staying at the Gateway) don't respect anything and are always partying (drinking, smoking weed) and leaving a mess all over the place. Officer Paoli made his way to the third floor in an attempt to locate Coronado. On the third floor, Officer Paoli observed a while plastic chair in the middle of the hallway covered in blood, but was unable to locate Coronado, even after announcing his presence on scene. Officers Pozas #3349 and Sanchez #3678 arrived on scene to assist. Officers observed a trail of blood leading from the plastic chair, down the hallway to a small alcove that had two more rooms. Officers observed the blood to stop in front of room 307. Officers knocked loudly and announced themselves but were met with negative results. Coronado emerged from a separate hallway. Coronado was suffering from multiple stab wounds to the chest, shoulder, and back and was bleeding profusely. Coronado was extremely uncooperative with the Officers and refused to answer any questions. Coronado just insisted on getting help for his injuries. FMS arrived on scene and assisted in transporting Coronado to University Medical Center for treatment. Officer Paoli conducted a follow up at UMC. While at UMC Officer Paoli was advised by medical staff that after tests and imaging services were conducted on Coronado, he was not in danger of expiring and that his wounds were not serious. Officer Paoli returned to the original scene and was shown security camera video footage of the incident. Officer Paoli observed a large altercation between 10-15 individuals break out in the third-floor hallway and Coronado and Carlos Andre Matutes exchanged words and the altercation turned physical, resulting in Coronado getting stabbed.

On Sunday June 16<sup>th</sup> of 2024, at approximately 1701 hours, Officers A. Castaneda #2727, D. Wesenberg #3086, A. Torres #3441 and A. Turrey #3496 while on patrol were dispatched to an aggravated assault in progress. Upon arrival the officers met with Ray (Hotel Clerk) who was sitting down across from the business. Ray said that it started with a car parked in front of the business and the subject used a chain to keep the front door open to make it easier to come in and out of the business as he was taking groceries. Ray unlinked the chain and tried to explain to the subject that they could not leave the door open as the heat comes in the building, the subject got upset and threatened him in Spanish "voy a agarrar un cuchillo y te voy a puñalar." Ray provided a description of a "migrant" male about 5'10 wearing a red and white shirt and shorts and was possibly wearing a cap but unsure about the cap. Officers talked to Chambless Jr. who was in the back and came to the front as he heard screaming and sounded like a possible fight. Chambless Jr. spoke to Ray who told him the subject said that he was going to get a knife. Chambless Jr. stayed inside and talked calmly to the subject and was able to calm him down. Chambless Jr. stayed inside and talked calmly to the subject and Chambless Jr. believed he could have a knife but that he never saw the unknown subject with a knife.

On Tuesday, June 18<sup>th</sup> of 2024, at approximately 0250 hours, Officers C. Chavez #3543 and R. Mendoza #3210 were dispatched to 104 N Stanton in reference to a burglary of habitation in progress. After determining there was no burglary, Officers located a small vial with a white powdery substance in the hallway. Officers believed and later confirmed it to be cocaine using test kit G. Officers weighed and submitted the vial as abandoned.

On Wednesday, June 19th of 2024, at approximately 1300 hours, Officers A. Lechuga Rincon #3406 and Affiant conducted a business check at 104 S. Stanton St. (Gateway Hotel). Officers contacted Rosselyn Lyda Ratjen (clerk for the hotel). Officers asked Ratjen if they could conduct a business check for the hotel, to which Ratjen stated the Officers could. Officer Lechuga Rincon asked Ratien if anybody was staying on the 4th floor of the hotel. Ratien responded nobody was supposed to be there due to it being condemned and everybody had been told to move out of the 4th floor and the deadline had been the beginning of June. Ratjen requested Officers to search for people on the 4th floor. Officers observed the 4th floor to have trash all around, along with furniture and mattresses around the hallway. Some of the rooms had empty beer cans, along with dirty mattresses with obvious signs of people sleeping on them overnight. Officers observed the door of room #405 to be closed but heard chatter coming from inside of it. Officers made contact and met with Jaqueline Young (Tenant not on any lease) and Luis Jose Jaramillo Zurita (Tenant not on any lease) who were inside the room. The room had property inside, a mattress, a dresser, operating AC unit, clothes hanging inside the room, and a microwave connected to the power outlet. Young advised she was living inside the room, but that she was moving out, and that Zurita was helping her. Officer Lechuga Rincon contacted Ratjen and asked her about Young and Zurita. Ratjen said everybody had been told to leave the 4th floor and Young needed to move out of the 4th floor that same day. Officer Lechuga Rincon relayed the message to Young.

On Wednesday, June 19th of 2024, at approximately 1355 hours, Affiant and Officer Lechuga Rincon #3406, were dispatched to the Gateway Hotel located at 104 S. Stanton St. in reference to a fight in progress. Upon arrival, Officers met with several parties at the front lobby of the hotel. Affiant contacted Elizabeth Butler (Tenant) who advised she was sitting outside in the lobby along with Raul Lopez-Corral (Tenant) and Cruz Anjelica Alvarez (Tenant) singing and chatting. Butler saw Jacqueline Young (Tenant) walking down from the stairs of the 2nd floor and noticed she was heading to the basement along with property. Butler knew Young was not paying rent and confronted her about it. Butler told Young she could not stay downstairs in the basement. Young got highly upset and started charging towards Butler punching her several times around her right side of the face. Butler punched back to defend herself. Officer Lechuga Rincon contacted Young who had been kicked out of the fourth floor of the gateway hotel due to it being condemned. Young advised she was placing her belongings in the basement for Alvin Ardell Chambless Jr. (Maintenance) to hold them for safekeeping and noticed Butler walked towards her. Butler was highly upset because she was telling Young she was not paying rent as others. Young argued back verbally with Butler and Butler charged towards her pushing her to the wall and punching her several times causing minor redness and scratches around her neck and upper chest area. Affiant asked Chambless Jr. and Alvarez if they had observed anything as they were with Butler but stated they only observed Butler go towards the basement hallway to argue with Young. Chambless Jr. stated he separated both Butler and Young as they were verbally arguing. Chambless Jr. observed injuries of both Offenders making him think they had

both gotten into a scuffle. Officers were not able to observe surveillance videos due to the cameras inside the hotel not working.

On Thursday, June 20th of 2024, at approximately 1000 hours, Officers A. Lechuga Rincon #3406 and Affiant, conducted a business check at 104 S. Stanton St. (Gateway Hotel). Officers D. Vargas #3363, R. Lerma #1952, J. Pedroza #3023, A. Greer #3196, C. Nava # 3213, Sgt. R. Hernandez #2378 and R. Escobar #3090 were also at the hotel to assist. Officers contacted Veronica Gutierrez (clerk for the hotel). Officers asked Gutierrez if they could conduct a business check for the hotel and Gutierrez stated they could. Officer Lechuga Rincon asked Gutierrez if anybody was still in the 4th floor of the hotel and she said nobody was supposed to be in the 4th floor but would like Officers to check all the floors including the basement, and to let her know if anybody was in the 4th floor. Officer Lechuga Rincon asked Gutierrez if she had a log with the people that were occupying each room and Gutierrez provided the Officer with a paper with all the rooms written down along the names (first name only) of the people at each room Gutierrez told the Officer approximately how many people where in each room and that she did not know if some of the rooms still had people living in them because they had not paid rent. She also said some residents kept bringing in people that where not on the hotel's records. Gutierrez gave the Officer a copy of the Fire Inspection Notice that the hotel received on 04-25-24. Officers noticed some of the rooms had extension cords coming out of the rooms, which ran through the hallway and were connected to electrical outlets along the hallway wall. The 3rd floor north fire exit was blocked with trash and broken furniture. Officer Lechuga Rincon notified Gutierrez of the issue. On the 4th floor, Officers observed the door to room #405 was locked. Officers knocked on the door, and Thomas Langley (not on any lease) opened the door. Langley had a pocket knife in his right jeans pocket along other sharp tools. Officers believed Langley was trespassing. Langley was detained and his knife and sharp tools were removed. Jaqueline Young was also inside the room. Both Langley and Young were encountered the day before (06/19/24) and were not supposed to be in the room. The room still had all the furniture and clothing the Officers had observed the previous day Gutierrez requested Officers to escort Young and Langley off the 4th floor.

On Thursday, June 20<sup>th</sup> of 2024, at approximately 2255 hours, Officers A. Morales #3067 and A. Chapa #2675 while conducting a business check along with other Metro Units at the Gateway Hotel (104 S. Stanton) met with Ricardo Linado Mazo (Tenant) who in plain view had a marijuana grinder and smoking pipe with residue on top of his dresser. Mazo stated he smoked marijuana earlier in the day but did not have any more on him or his property. Officers issued Offender a Class C Citation (33713440) for the drug paraphernalia. Officers submitted the drug paraphernalia at CRCC mailbox as evidence.

On Sunday, June 23<sup>rd</sup> of 2024, at approximately 0210 hours, Officers A. Morales #3067 and A. Chapa #2675 were dispatched to 104 S. Stanton (Gateway Hotel) in reference to an assault call. Upon arrival, Officers met with Rosselynn Lyda Ratjen (Tenant) who advised Officers that maintenance man had pulled an extension cord from her ceiling after arguing with her about her air conditioning system. Reporter stated the extension cord struck her on the left side of the face.

On June 25<sup>th</sup> of 2024, at approximately 1055 hours, Officers A. Lechuga Rincon #3406, conducted a business check at 104 S. Stanton St. (Gateway Hotel). Officers D. Vargas #3336, J. Pedroza #3023 and A. Greer #3196, C. Nava # 3213 and R. Escobar #3090 and Sgt Hernandez #2378 were also at the hotel to assist. Officers contacted Veronica Gutierrez (clerk for the hotel). Gutierrez told Officers they could conduct a business check. Gutierrez stated nobody was supposed to be on the 4<sup>th</sup> floor. Officers observed the door to room #332 to be open. Daniel De Jesus Ariza Ayala, Stephani Dixberli Gurrola Morales and Ricardo Lindado, subjects from Venezuelan were inside the room. Ayala and Lindado said they worked for the hotel, and that they were working on the room. Morales said she cleaned for the hotel. Officers smelled burnt Marijuana inside the room. Ayala and Lindado stated they smoked Marijuana earlier in the day, but did not have anymore. Officers did not observe any Marijuana inside the room. Officers observed the door to the 4<sup>th</sup> floor to be pried open. There was a gooseneck wrecking toolbar close to the door. No subjects were located on the 4<sup>th</sup> floor of the hotel.

On Thursday, June 25<sup>th</sup> of 2024, at approximately 2254 hours, Officers D. Wesenberg #3086 and A. Castaneda #2727 arrived at 104 S. Stanton (Gateway Hotel) in reference to daily hotel checks for the property. The officers observed Pedro Enrique Rojas-Carmona (Tenant) sitting in a lawn chair holding a cigarette to his lips but did not actually smoke the cigarette before he was advised by the officers that smoking is not allowed inside any business in the city of El Paso. Rojas-Carmona was asked if he lived in the building and Rojas-Carmona stated that he lives a couple of rooms down and then walked into his apartment (#303) to provide the officers with his positive identification. Rojas-Carmona told the officers that he did not know it was against city and hotel policy to smoke a cigarette inside the hotel. Rojas-Carmona continued to tell the officers that everybody smokes and he was unaware of the rules. The officers stated that hotel management has a zero-smoke policy within the building and it is also against city ordinance to smoke inside a public building within the city limits of El Paso.

On Tuesday, July 2, 2024 Officers R. Escobar #3090 and C. Nava #3213 were dispatched to 104 S. Stanton in reference to a criminal trespass in progress. The Officers arrived on scene and met with Veronica Gutierrez who stated the last time the Officers were there, she had a subject who was criminally trespassed walk into the hotel with a group of other individuals. Gutierrez told the subject, "You cannot be in here, you need to leave". Gutierrez stated that the individual kept walking upstairs and that is when she called police.

The Officers asked Gutierrez where was the subject was located, she stated that he went to the 4th floor then watch him on the cameras leave out the back door into the alley. The Officers checked the alley area for the subject but were unable to locate the subject.

On Wednesday, July 3, 2024, Officers R. Escobar #3090, A. Lechuga Rincon #3406 and Affiant conducted a follow up in reference to the Criminal trespass at the listed address at approximately 9:30hrs. The Officers arrived on scene and met with Ray who played the video footage of Burgos-Morales coming into the hotel. Officers Lechuga Rincon and Affiant viewed the camera footage and positively identified Burgos-Morales who entered the hotel along with three other individuals. The investigation revealed that the listed offense had occurred.

On Wednesday, July 3<sup>rd</sup> of 2024, at approximately 1650 hours, Officers A. Torres #3441, A. Turrey #3496, A. Castaneda #2727, D. Wesenberg #3086, R. Castro #2727 and B. Ramirez

#3159, were dispatched to 104 S. Stanton in reference to a criminal trespass in progress. Officers where advised by dispatch that the subject was a Venezuelan male approximately 25 years of age by a name of Brian wearing a grey shirt and blue jeans. Dispatch had also advised that day shift Officers had previously attempted to locate the subject earlier in the day but were met with negative results. Responding officers located Burgos-Morales on the first floor in room B and made contact. While Officers spoke to Burgos-Morales, Officer Torres was flagged down by Gutierrez (Manager of Hotel). Gutierrez pointed at a live surveillance feed and stated "That's him, that's Brian" and pointed at Burgos-Morales on the screen. Officer Torres then went back to room B and placed Burgos-Morales into handcuffs to detain Burgos-Morales to further investigate. Burgos-Morales was escorted outside of the business by other officers while Officer Torres gathered information from dayshift officers about the listed Burgos-Morales's on-going criminal trespass investigations. Due to the fact that Burgos-Morales did not have a valid picture ID on him and because he matched the description of the subject previously investigated for criminal trespass, Burgos-Morales was transported to CRCC for paperwork. While at the station, Officers determined that Burgos-Morales's criminal trespass investigations are still on-going pending additional information. (See Field Contact # 24-0439 and Case # 24-185057). Burgos-Morales was then released from the station along with his property. Burgos-Morales was advised his case is still under investigation and would be documented. Burgos-Morales was then given a trespass warning on behalf of The Gateway Hotel due to the fact the Gutierrez advised that she had told Burgos-Morales several times already that he was not allowed to be at his business and that he needed to leave. Burgos-Morales stated that he understood what the warning meant and that he would not go back.

On July 14, 2024, at approximately 2300 hrs., Sergeant C. Nelms #2150, rode past 104 S. Stanton St. (Gateway Hotel). While riding past the hotel, Sgt. Nelms observed a subject shouting from the front entrance area to the hotel. Sgt. Nelms approached and observed two males and one female standing outside of the front doorway to the hotel. Sgt. Nelms stopped his bicycle to hear more clearly what the individuals were yelling. The female individual was shouting upward towards open windows of hotel rooms as if indicating for someone to come downstairs to open the door. The two male individuals were trying to open the front door by pulling on the front door, but Sgt. Nelms observed the door to appear to be locked. The female individual stopped shouting, turned toward Sgt. Nelms, and began dancing to music that one of the male individuals was playing. The female then started telling Sgt. Nelms to "bailar... bailar", which is Spanish for "dance... dance...". Sgt. Nelms observed the music playing to repeat the phrase "policia" several times, Spanish for police. Officers A. Perez #3482 and A. Hernandez #3468, then arrived to the scene and observed several hotel occupants looking down from the hotel at officers from the open windows. Officers attempted to make entry to the hotel lobby, in order to conduct a business check of the listed premise, but observed the door to be locked. Officers then knocked several times so that an employee would open the door but were met with negative contact due to the front desk and surrounding area being unoccupied. As officers were preparing to leave, the observed a male subject walk downstairs to open the front door to the hotel for the three individuals that Sgt. Nelms observed outside initially. After allowing the subjects in, the male subject then ensured that the door was again closed and locked. Officers again observed there were no employees at the lobby desk or in the surrounding area of the entrance.

On August 3, 2024, at approximately 1015 hours, Officers R. Elicerio #2246 and J. Alvarez #2602 were conducting a business check at 104 S. Stanton. Officers were assisted at the scene by Lt. S. Rangel #2482 and Officer R. Escobar #3090. Upon arrival, officers met with the front desk clerk, Victor Ray who immediately advised of continuous noise disturbances and drinking on the second floor late into the night (until 4 am). Officers asked the front desk clerk if it was ok for the officers to go and check the floors upstairs. Officers went upstairs to the second floor and did notice several empty beer cans and cigarette butts throughout the floors, especially outside of rooms 221 and 219. Officers proceeded to the third floor where they observed several furniture items on the hallway as well as piles of trash blocking a fire exit on the third floor. Officers noticed several empty beer cans and cigarette butts outside of room 302 and knocked on the door to meet with the occupants (Raul Jose Salazar-Velasquez and Oriadna Borjas-Rodriguez) in that room. Officers met with the occupants in room 302 and they stated that they had just rented the room for two hours and had no idea about the empty beer cans. Officers continued to check the fourth floor as well as the roof top and they checked ok. On their way down, on the second floor, Officers met with Junior Jose Salcedo-Mojica who advised he was trying to get a better signal for his phone, and he lives on the third floor in room 315. Officers asked Junior Jose Salcedo-Mojica for an ID and he said it was in his room. Officers went upstairs and met with Lonnie Alejandro Villanueva-Rodriguez (Salcedo-Mojica's roommate). Officers had noticed a tattoo in Salcedo-Mojica's left forearm associated to the Train De Aragua gang. Officers also noticed a tattoo a rose to Salcedo-Mojica's right neck area. After meeting with Villanueva Rodriguez, officers noticed a tattoo of two names with a five-point crown on his right forearm (inside). Officers asked the meaning of the tattoos, and he stated it was his daughters' names.

On Thursday August 23, 2024 Affiant, Officers R. Elicerio #2246 and J. Alvarez #2602 responded to a domestic violence call for service that turned out to be civil in nature and no assault had occurred. As Officers were walking out of the building on the second floor, they noticed a couple of Venezuelans (Frandi David Lucena Caruzi and Vicmary Yesenka-Torres Martinez) walking out of their room #210. Officers noticed cooking fumes coming out of the room and contacted them. Officers asked why they were cooking inside their small bedroom as they had been told by the El Paso fire marshals that they are not allowed to cook inside the tenant's rooms, especially if they are propane propelled portable hot stoves. Caruzi stated he is allowed to cook their food inside their rooms since he was given permission by the front desk management. Caruzi, had a crown tattoo on his arm along with paw tattoos. Affiant and my partner have noticed a trend of Venezuelans that carry the same tattoo representing Tren De Aragua Gang association. Upon stating the facts of the above-mentioned calls for service, criminal incidents along with business checks, these incidents demonstrate all of the criminal activity that's occurring based on Officers encounters each time at the Gateway Hotel. Thru my training and experience I can easily say there's a very high level of Drug activity happening from drug addicts squatting on the condemned floors. We have contacted subjects that are sleeping on the vacant rooms with obvious signs of disorientation, due to them being high on narcotics, with clear glass pipes and small plastic baggies next to them.

There should be concern due to the establishment and rise of the Venezuelan Criminal Organization "Tren de Aragua" at the Gateway Hotel. We discovered several Venezuelans have

the tattoo identifiers of Tren de Aragua. Myself and my partner Lechuga Rincon have contacted more than ten Venezuelans claiming to work at the hotel in order to be able to pay rent. As we contact them we track and document all of their tattoos which represent different ranks in the criminal organization some examples being: Basketball athlete "Michael Jordan #23 Logo" representing the revolution Aragua, Venezuela. AK47 tattoos representing their strongest caliber gun Aragua members like to use when committing aggravated assaults. Star tattoos representing high level rank within Tren de Aragua. And many Venezuelans with grenade tattoos representing their criminal organizations to be bulletproof. And finally, many Venezuelans with Train tattoos representing their name of the Gang Tren de Aragua or Train of Aragua.

Through Officers training and experience we suspect there is Prostitution happening inside the Gateway hotel. A Venezuelan female suspected of running prostitution, has been seen coming out of the hotel multiple times and get picked up by multiple vehicles, then dropped off several hours later. The female has been seen at the Sacred Heart Church area going in with multiple Venezuelan males into the port-a-potties in past incidents. After speaking with different Venezuelans in the area, they state that the female offers sex for money. We confirmed the female lives at the Gateway Hotel with her kids. Further, several subjects have told us about the high activity of narcotics, prostitution and weapons occurring inside the hotel. All subjects have become uncooperative in providing their information to law enforcement as they want to remain anonymous due to fear of retaliation from the criminal organization.

In Conclusion, what I believe would happen if the Gateway Hotel were allowed to remain operating would be continuous incidents of criminal activity like aggravated assaults. Even in prior years there was high level of calls for service from the hotel regarding subjects consuming methamphetamine and assaulting each other, with criminal activity increasing with the introduction of the Tren de Aragua organization into the hotel. I think there would still be problems there because the building is not well maintained for living conditions. Since they don't charge 100 percent for rent, usually homeless, Venezuelan gang members with low-income wages will choose to live there causing them to start criminal activities in order to generate income. Other than the criminal activity, if it remains open, it is so hazardous that pretty soon a child or a teenager will have an accident due to the windows not having screens and no locking mechanism to keep them from kids accidentally falling from the windows or the side stairs.

Before me the undersigned authority, on this day, personally appeared Officer Dionicio M. Alvarez #2285, who being duly sworn and upon oath stated:

"My name is Dionicio M. Alvarez #2285. I am over 21 years of age, of sound mind, capable of making this affidavit, and have personal knowledge of the facts stated within this document. I affirm the facts stated herein are true and correct to the best of my knowledge and I am competent to testify to these facts.

Affiant is employed as a Police Officer with El Paso Police Department in El Paso County, Texas and has been employed as such since August 2002. Affiant is presently assigned to the Community Relations Unit as a Police Area Representative ("PAR") in El Paso, Tx.

Unless otherwise indicated, this affidavit describes the participation of PAR, Affiant in full uniform operations at the Gateway Hotel located at 104 S Stanton, in the City of El Paso, El Paso County, TX. 79901. The purpose was to investigate criminal violations that have occurred in this location. Any mention, in this affidavit, of criminal activity or violations further details of the investigations and conversations, noted below, are in El Paso Police Department reports.

On 7/01/24, Officer D.M. Alvarez #2285 Affiant arrived to Gateway Hotel at approximately 12:45 p.m., The Affiant entered the Gateway Hotel for a regular business check. Once inside Affiant observed several people behind the courtesy desk looking through paper work. Affiant did not observe any type of uniform nor any type of logo displaying on their person or clothing to show these people worked for Gateway Hotel. Affiant asked for the manager of the Gateway Hotel and was referred to Veronica Gutierrez who confirmed to she was the manager. Affiant asked if the people behind the desk were employees and learned that they assist the manager during working hours. Affiant checked the elevator in order to get to the second floor and learned that the elevator has not been in service for over a year due to maintenance upkeep. Affiant took the stairwell to get to the 2<sup>nd</sup>, 3<sup>rd</sup> and 4<sup>th</sup> floor, which appeared to be unstable and dangerous for the public to walk on. During the duration of the operation/business check, Affiant walked upstairs and observed trash throughout 2<sup>nd</sup>, 3rd and 4<sup>th</sup> floor. Affiant checked the emergency exit and observed trash on the fire escape blocking access to the fire exit stairs. Affiant, while walking up to the 3rd floor found 2 children of ages 8 to 12 years of age in the stairwell playing games on their cell phones blocking the entrance to the hallway. Affiant asked if they were ok and the children in the stairwell stated that they were and continued to play games on their cellular phones. Affiant did not observe any type of supervision to the children on the stairwell. Affiant continued the check and observed several males speaking Spanish with an accent different than what Affiant is familiar to in El Paso, Tx. Affiant discovered several Venezuelans that had tattoo identifiers of Tren de Aragua, a gang affiliated to Venezuela. Affiant observed males walking through out the hotel with tattoos associated with the criminal organization known as "Tren de Aragua", Affiant made contact with manager (Veronica Gutierrez) of Gateway Hotel and advised her of the trash blocking the fire exits. Affiant also observed, on the 3<sup>rd</sup> floor, empty beer cans and clear plastic baggies corners torn in a manner commonly used to hold narcotics. Affiant also learned that the males walking around are employees that work for Gateway Hotel in order to pay for their stay at the hotel. Affiant observed the employee/tenants did not have a uniform or clothing with any type of logo to show employment by Gateway Hotel.

On 7/02/24, Affiant arrived to Gateway Hotel at approximately 12:30 p.m. for a trespass in progress. Affiant checked the Gateway Hotel and met manager Veronica Gutierrez who advised said the offender (trespasser) left and was a visitor of an occupant of the Gateway Hotel. Affiant checked the business and observed trash throughout the hallways on the 2<sup>nd</sup> and 3<sup>rd</sup> floors. Affiant informed the manager of the trash that blocked emergency exits. Affiant did not locate a trespasser. Affiant also informed the manager that on the 4th floor, Affiant observed empty beer cans and clear plastic bags that had their corners torn in a manner commonly used to hold cocaine. Affiant explained that there should be no one on the 4th floor due to it being condemned. The manger stated that no one is up on the 4th floor, but after approximately 23:00 hrs, when management leave, unknown residents, possibly transients, make their way to the 4th floor and leave prior to 7:00 a.m. Affiant explained to the manager that there should be no one on the 4th floor for their safety. The manager agreed and informed Affiant the owner of the property did not want to pay for security after hours and bad things happened in the late hours of the night. Affiant explained to her that tenants need to call 9-1-1 if there are illegal activities happening late hours at the Gateway hotel.

On 07/11/2024, Affiant arrived to Gateway Hotel at approximately 19:00 a.m. to assist Fire Marshalls, Code Enforcement and the City of El Paso Building inspectors on a business check and Affiant provided escort.

Affiant learned through the fire marshals investigation (ENFD24-00240) that the hotel was found in violation. Affiant also learned that Code Enforcement and building

inspectors created cases for building noncompliance on several violations. Code Enforcement case number is ENEC24-30248, reference to trash in hallways and trash blocking fire exit.

On 7/19/24, Affiant arrived to Gateway Hotel at approximately 14:30 p.m for a regular business check. Affiant walked upstairs to check the business and observed trash throughout the 2<sup>nd</sup>, 3rd and 4<sup>th</sup> floors. Affiant checked the emergency exit and observed trash on the fire escape blocking access to the fire exit stairs. Affiant made contact with manager (Veronica Gutierrez) of Gateway Hotel and advised her of the trash blocking the fire exits. Affiant also smelled burnt marijuana coming from the 3<sup>rd</sup> floor but was unable to determine the exact location. The manager advised Affiant that they hired security that was in plain clothes and checks all floors and helps with maintenance. The manager stated that security will check on the smell of the unknown marijuana coming from the unknown floor and deal with it if were to happen again. Affiant advised the manager again to call 9-1-1 if there is any illegal activity that is occurring and the police department will take the appropriate steps to or such actions.

On 7/22/24Affiant arrived to Gateway Hotel at approximately 15:00 p.m. for a regular business check. Affiant walked upstairs to check the business and observed trash throughout 2<sup>nd</sup>, 3rd floor. Affiant checked the emergency exit and observed trash was still on the fire escape blocking access to the fire exit stairs. Affiant made contact with manager of Gateway Hotel and advised her, again, of the trash blocking the fire exits.

On 8/07/24 Affiant arrived to Gateway Hotel with Code inspections officers at approximately 13:30 p.m., to assist code inspectors on a follow up to previous check.

Affiant walked upstairs to check the business and observed trash throughout 2<sup>nd</sup>, 3rd floor. The officer checked the emergency exit and also observed trash on the fire escape blocking access to the fire exit stairs were cleared. Affiant made contact with manager of Gateway Hotel and advised her of the trash blocking the fire exits. The Affiant observed on the 2<sup>nd</sup> and 3<sup>rd</sup> floor empty beer cans and packaging associated with cocaine that were always in different locations at different times and dates. The Affiant observed occupants that were walking appeared nervous as Affiant checked the business. The occupants quickly walked away from Affiant to a room and closed the door quickly.

On 8/09/24, Affiant arrived to Gateway Hotel at approximately 13:10 p.m. for a regular business check. Affiant walked upstairs and observed trash throughout 2<sup>nd</sup>, 3rd floor. Affiant checked the emergency exit and observed trash on the fire escape blocking access to the fire exit stairs. The Affiant made contact with manager of Gateway Hotel and advised her of the trash blocking the fire exits. On every visit Affiant observed the same issues of trash in trash bags lined in the hallways of the 2<sup>nd</sup> and 3<sup>rd</sup> floor. Empty beer cans on different floors, along with different types of drug paraphernalia, ex: clear empty plastic baggies, broken crack pipes, cigarette paper known for use of marijuana blunts. Affiant made it clear to the security on duty and the manager that these illegal activities cannot be ignored and need to be addressed. The manager stated that she is aware but the activities occur in the late hours of the night when she is not there. Affiant was advised that security only is on duty early evening hours and is not employed late hours when the illegal activity occurs. Affiant knows management is aware of criminal activities occurring late at night, but has made no effort to change the schedule of security due to owner not wanting to pay for late night security. After each inspection by Affiant trash accumulation, blocked fire exits, and drug/alcohol paraphernalia increased and did not improve.

Overall, management is not attempting to control the conduct of the guests, and is negligently allowing gang activity to infiltrate the area. Affiant has learned that Gateway Hotel has gained a reputation for allowing illegal activity (consuming drugs, gang activity, illegal dumping) and known not to make the necessary changes to prevent the illegal activities. If allowed to continue this creates a grip for increased organized crime and more violent crimes, which are already starting to occur. This is clearly affecting the neighborhood and downtown area, ultimately threatening public safety.

Affiant believes from his training, experience, and observations inside the establishment that the employees of the location are conducting and allowing these violations to occur. This establishment will continue to threaten public safety if allowed to conduct "business as usual."
